Dear Parent/Guardian:

Your student has expressed an interest in the Career and Technology Center's **Cosmetology** program for the next school year. This is a **three-year program** beginning in the 10<sup>th</sup> grade and students that are accepted into the Cosmetology program must complete the entire three years. According to State Board regulations, only a limited number of students may be enrolled.

In order for your child to be considered for the Cosmetology program, this form **MUST** be completed and returned to our school by March 1, 2021. This form can be scanned and emailed to **[clatsch@andersonctc.org](mailto:clatsch@andersonctc.org)** or delivered to your high school counselor. This form will only enable your student to be eligible for consideration; it does **NOT** guarantee them a place in the class.

Please be aware that the total cost of the program is \$675 which can be paid over the three years at \$225 a year. Fees are used to pay for student kits, licensing exams, lab coats and other supplies. To receive their state license, students must pass the state licensing exam and complete the State Board required 1,040 hours. The exam includes both theory and practical applications which are very rigorous. Due to the State imposed increase of the required hours; it is paramount that students recognize their commitment for the next 3 years. If there is a financial need we do have other payment arrangements and grants, therefore please do not allow the inability to pay to prevent your student from requesting this class.
